Background

Jagat Guru Nanak Dev Punjab State Open University (PSOU), Patiala, a State University for open learning in Punjab, has been established under an Act No.19 of 2019, notified vide Notification No.23-Leg/2019, dated 20.12.2019, by the State Legislature of Punjab and is empowered to award degrees as specified by the UGC under Section 22 of the UGC Act 1956.

SCOPE

- 1. The audit would cover all accounts of the University.
- 2. Assistance in financial accounting as per following:
 - a) Receipts of funds e.g. fees and grants and its disposition.
 - b) Development of accounting controls in consultation with the appropriate authorities.
 - c) Consultancy in accounting matters as per law governing the University.
 - d) Payroll activities.
 - e) Prepration of income and expenditure accounts, receipt and payment account, balance sheet and Utilisation certificate as prescribed by the law governing the University.
 - f) Consultancy in banking operations.
 - g) Maintenance of all statutory accounts.
- 3. Income tax compliance
 - a) Filling of TDS returns ,Form 16 and other related matters in this regards.
- 4. GST Compliance.
 - a) Filing of GST returns as applicable from time to time and other related returns.
 - b) Consultancy in financial matters, financial planning, Budgeting with appropriate authority from time to time.
- 5. Other relevant matters as mutually decided from time to time.
- 6 Audit shall be required to ensure that Goods and Services have been procured in accordance with relevant provisions of the University.
- 7. Audit will be required to give its opinion as to whether Balance Sheet, Income & Expenditure account and Receipts & Payment account of period of under Audit, read with Accounting policies give True and Fair view of State of affair of the University.
- 8. The Chartered Accountant firm so appointed would be required to look into the compliance of previous audit objections raised (if any) and have to verify or comment on the supporting documents/ vouchers submitted on latter stage, to settle the audit qualifications in the Statutory Audit report of this assignment

JURISDICTION

In all matters and disputes arising hereunder the appropriate Courts at Patiala alone shall have jurisdiction to entertain and try them.

OTHER TERMS AND CONDITIONS
