- 8. Payment shall be made in Indian rupees on Final acceptance & after verification by the specified consignees and their issue of clearance & acceptance certificates to the satisfaction of the authority.
- 9. If the material is not delivered on or before the due date the competent authority will have the right to deduct 2% of the total bill for every weeks default. The decision of the University shall be binding on the bidder in this regard.
