- 2. The bidder shall strictly abide by the time schedule given by university for delivery of the material /Items as per work order.
- 3. Validity of the bid is 90 days from the date of opening quotation.
- 4. Selected bidders are strictly prohibited for subletting the assigned work/work order.
- 5. Incomplete and conditional Quotation will not be accepted.
- 6. The Registrar, Jagat Guru Nanak Dev Punjab State Open University, Patiala reserves the right to cancel the bid without assigning any reason.
- 7. Copy of Pan Card & GSTN must be attached.

- 8. Payment shall be made in Indian rupees on Final acceptance & after verification by the specified consignees and their issue of clearance & acceptance certificates to the satisfaction of the authority.
- 9. All the material ordered shall be delivered within 10 days from the date of receipt of work order. All the aspects of safe delivery shall be the exclusive responsibility of the supplier. If the supplier fails to deliver the goods on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value.
- 10. The decision of the University shall be binding on the bidder in this regard.
- 11. TDS is applicable as per Income tax rules.
- 12. Quotations will be opened on 05.12.2024 at 3:00 PM in the committee room of the University i.e. Jagat Guru Nanak Dev Punjab State Open University 28-C Lower Mall Patiala. The firm or its representative can attend the opening of the quotation.
- 13. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, GST and other taxes rates in respect of the supplies. The University shall not be liable to pay any tax, freight etc. Which has not been expressly stipulated in the quotation.
- 14. All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator i.e, the Registrar JGNDPSOU Patiala. The award of the sole arbitrator shall be final and binding on both the parties under the provisions of the Arbitration and Conciliation Act, 1996 or by statutory modification reenactment thereof for the time being in force. Such arbitration shall be held at Patiala.
- **15.** Sealed Envelopes should be super-scribed as "Tender for Printing & Supply of Calendar & Diary".
- **16.** All the bids in sealed format only will be accepted.
- 17. A very high quality of printing is required. The work done in slipshod manner will not be accepted.
- 18. The firm will be entirely responsible for quality of supplied goods/ materials. The supplier should replace the rejected/ damaged goods within 10 days, failing which penalty will be imposed by the Institute.
